**July 28, 2024 in Bengaluru**

Laghu Udyog Bharati-Karnataka Office Bearers met with Finance Minister Smt. Nirmala Sitharaman during an interactive meet organised for a select group by BJP Karnataka Economic Cell on July 28, 2024 in Bengaluru.

LUB-K submitted a detailed representation to the finance minister. The Minister responded very positively to all the suggestions put forth by LUB-K. A few of the points raised with FM included: Drop in the Budget Outlays esp. on MSME Schemes, Customised MSME schemes, CGTSME scheme, Section 43 B(h) of Income Tax Act to name a few.

Following points were discussed by the LUB Karnataka team with Finance Minister:

1. There is significant drop in the Budget Outlays for some of the very important schemes which will hamper the growth and performance of MSME – we submitted the names of some of the schemes which needs rethinking of Budget Outlays.
2. We highlighted the importance of PMEGP scheme and how the Budget outlay on that scheme has been drastically reduced. For this Madam replied saying that the scheme was not getting fully utilised properly and so they decided to reduce the outlay. We countered it by mentioning that as per the feedback we receive from the young entrepreneurs who approach the financial

institution for PMEGP loan they put forth some of the conditions which are not initially part of the scheme and so they are not able to utilise the benefit of the scheme.

3. We also expressed our views on how the financial institutions are giving importance only to their Customised MSME schemes and not to the MSME schemes of the Government. Madam replied stating that she will ask the Banks to look in to this concern.
4. Raised a point on CGTSME scheme wherein according to the scheme, the Financial Institutions will be putting for the terms and conditions on selecting the viability of the project and the government only is restricted to guarantee part for the loan sanctioned. Due to this it is becoming difficult for lot of Small and Micro entrepreneurs to avail the CGTSME benefit due to cumbersome process of fulfilling the terms and condition put forth by the Financial Institutions. Madam replied by saying that better approach SIDBI in case of such type of issue. She also said that it is not required that the where ever we approaching for such loans SIDBI Branches should be there. We can approach SIDBI branches located anywhere for assistance.
5. We also asked the clarification on Section 43 B(h) of Income Tax Act which deals with 45 days payment time line for MSME payment. She replied that this provision was introduced as per the suggestion of LUB and since nothing was mentioned in the Union Budget speech the say provision continued as per 2023-24 Budgets.

LUB Karnataka was given the opportunity to conduct the session on Import Substitution & Indigenization at the LUB Sangamam wherein about 1000 members from all southern states had taken part. The distinguished panelists were Shri. Sundaram of Swadeshi Jagran Manch, Lt. General. P.R. Shankar Prof. Aerospace Department IIT Chennai, Shri. Prabhu Ponnuram, Regional Procurement -Lead, HydraSpecma India Pvt. Ltd., Shri. V. Ramesh Kumar, Scientist G, Additional Director (Gun Control System) CVRDE Chennai. The session was moderated by Shri. B.S. Srinivasan Vice President LUB Karnataka.



Shri. B.S. Srinivasan set the tone for the discussion by stating the point that India imports about 176000 crores worth capital equipment and the Ministry of Heavy Industries GoI is having a plan to



cut down imports by indigenization of a minimum of 18000 crores in the next five years, this project will have involvement MSMEs, PSUs, MNCs and Academic Institutions in close collaboration. The Defence PSUs have more than 34226 items that need to be indigenized under Make in India program to achieve Atma Nirbhar goal set by PM Sri. Narendra Modi.

Shri. R. Sundaram, National Convenor of Swadeshi Jagaran Manch explained to the audience the unfair means used by China in subsidizing exports and dumping in the world market. He also emphasised the need for the Government of India to focus on import substitution which can increase the manufacturing contribution to GDP leapfrog to 20% in the next few years, thereby increasing employment opportunities for youth.

Shri. V. Ramesh Kumar, Scientist 'G' Additional Director (Gun Control System) enlightened the participants about the purchase preference for MSMEs and handholding of MSMEs in new product design and development for the requirement of Combat Vehicle Research & Development, Government of India.

Shri. Prabhu Ponnuram, Regional Procurement-Lead, Hydra Specma India Pvt. Ltd. presented the scenario for import substitution in the Wind Energy sector in India which is expected to grow from 47GW to 132 GW in the next 5 years, also the opportunity for supply of spares and maintenance of existing Wind Turbines is a big business for MSMEs.

Lieutenant General P R Shankar, PVSM, AVSM, VSM, ADC & Professor of Practice in the Aerospace Department of IIT Madras delivered an address which captivated the imagination of the MSMEs. He spoke on how the Government of India through the Ministry of Defence to support MSMEs in design and develop import substitution and indigenous products needed for Indian Defence PSUs. He elaborated on the point of dual use of technology, that there is almost 90 percent overlap in technology used in civilian and military. The requirements of components, sub-assemblies and parts for Brahmos, Akash, Pinaka & Attack gun systems for Defence exports, spares for Russian Defence equipment which are widely used in about 50 to 60 countries around India, Maintenance of Defence equipment by MSMEs is another business avenue.

## Interactive Session with Ms. Liza Maria Powell, Director – Trade & Investment | Education, Australian High Commission



The Toyota Production System (TPS) was established based on two concepts: The first is called "jidoka" (which can be loosely translated as "automation with a human touch") which means that when a problem occurs, the equipment stops immediately, preventing defective products from being produced; The second is the concept of "Just-in-Time," in which each process

produces only what is needed by the next process in a continuous flow. Based on the basic philosophies of jidoka and Just-in-Time, the TPS can efficiently and quickly produce vehicles of sound quality, one at a time, that fully satisfy customer requirements.

Shri. Thejkumar said that that working with TPS allows companies to produce high-quality, cost-effective products, that are delivered to customers on time. The production respects the environment, which includes recycling of products at the end of their lifetime. And it also creates a safe workplace, both for the employees and the customers.

At the Toyoda facility, the visiting delegates experienced how meticulously each of the processes is planned at the manufacturing unit to roll out end-to-end finished product

The industrial visit is part of Laghu Udyog Bharati-Karnataka's member-connect programme, wherein best practices are shared with member companies so that they replicate the top-end manufacturing culture back at their own plants.



Additionally, this process improves the functionality of the metal and is often used for aesthetic purposes. For example, metal can be treated in preparation for painting and coatings depending on the desired look of the components.

Delivering the welcome address Dr. Sachin Sabnis commending the efforts of the Bengaluru North team for putting up an excellent show said that in 2023, the surface treatment market in India was valued at \$382.48 million, and is expected to grow at a CAGR of 5.94 percent through 2029.

There are many reasons for wanting or needing a coating on a material or product. Depending on the application, properties such as increased hardness, wear resistance, increased or decreased friction, or a change in thermal expansion or thermal conductivity can greatly enhance the usability of the substrate.

The market for surface treatment is broad, with a range of technologies and techniques targeted at enhancing surface qualities for distinct uses. The need for innovative surface treatment solutions is driven by the expansion of industries such as aerospace, automotive, and construction. The industry is growing thanks to advancements in coating technologies such as nanocoating and sophisticated polymers. Heightened awareness of sustainable and environmentally friendly surface treatment methods. Dominates the market as a result of robust automotive and aerospace industries and advanced manufacturing sectors.



**Ms. Reshma KS** research scholar at Bangalore university with professional experience of 13+ years in apparel industry & fashion institutes.




### Outcome of the first batch
